

1. The Program has issued notices to 1,727 incomplete claim packages, which is 66% of all Level 1.5 and Level 2 claims and 61% of all other claims.

5. The Program has audited 1,186, or 44%, of all claims, including 589 claims removed from audit and put back into the claims review process, 189 claims currently in Audit Investigation, 218 claims on Adverse Audit Reports with the Parties or Special Masters for Review or awaiting a response from those audited and 190 claims denied after audit.
