

Redesigned Settlement Website

We launched a fresh look for the official website of the Settlement Program on November 7, 2018. We simplified the site's organization, changed its colors and added new features. There are no more "Quick Link" icons; instead, there are simplified menu choices. The table at the end of this Alert explains changes from the previous site to the new one.

Also, you now have two ways to search:

1. "Site Search" (upper right-hand corner of the screen) lets you search all content on the website. You can limit results based on these 10 categories:
 - (1) Frequently Asked Questions;
 - (2) Court Filings;
 - (3) Forms and Instructions;
 - (4) Newsletters;
 - (5) Governing Rules;
 - (6) Alerts;
 - (7) Reference Guides;
 - (8) Published Decisions;
 - (9) Reports and Statistics; and
 - (10) Other Results.

2. "Page Search" (search box will appear in center of the page graphic on those pages with searchable material) allows you to search for things on a particular page of the website. You will see results only for that page. For example, if you do a page search on the Alerts page, you will see results only in the "Alerts" category.

After you do a search and get some results, use the "Exact Phrase" checkbox on the Search Results page to narrow your results to only those items that contain the exact word or group of words as you have entered them.
