

Details of Enhancements

We made enhancements to the official website of the Settlement Program on May 8, 2023. In an effort to make the site easier to use, we simplified the menu options, reorganized some of the pages, and added new functionality. Here is a summary of the changes:

- 1. FAQs Page.** We added up/down arrows to help visitors expand/collapse the FAQ sections. We also added a new “Recently Updated” category of FAQs to draw attention to those FAQs that have been added or updated in the last six months and a “Most Frequently Viewed Questions” section on the page with FAQs that have received the most clicks.

- 2. Menu Options.** We split the old “Documents” menu option into “Governing Documents” and “Useful Information” and added new menu options for the Settlement Agreement and a link to the PACER/MDL 2323 docket.

As part of these changes, we also simplified the old “Published Decisions” and “Court Filings” menu selections so visitors can click on each option. The table below shows the old and new menu options.

- 3. Governing Decisions Page.** We placed all Special Master and Court decisions on a single page, separated by two tabs, one for “Special Master” and another for “Court.” On each tab, you can click the buttons to view decisions by subject.

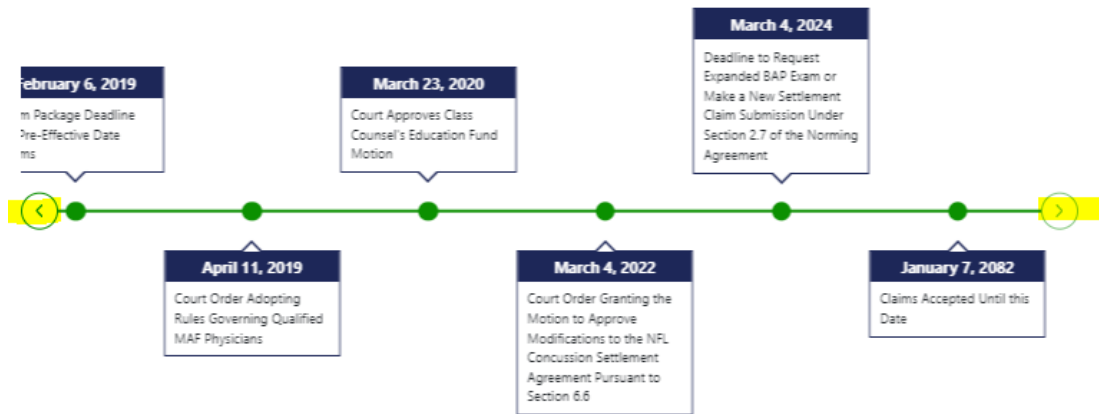

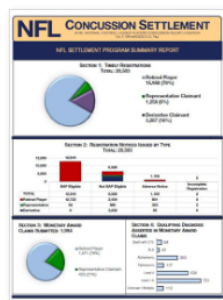

9. Reports & Statistics Page: We have reorganized the weekly Summary Report available on the Reports & Statistics page of the Settlement Website to provide a better user experience. All of the original information remains in these reports, but we updated the presentation of the data to:

- (a) Lead with payment information in Section A;
- (b) Separate the Supplemental Claim information from the initial Monetary Award Claims, and Supplemental Claim data will now be in a stand-alone Section C; and
- (c) Move the Registration information at the end of the report as Section D because the Registration period ended on August 17, 2017.
